ORDER

- 1. As per paper read (1) above, the Revised Regulations for U.G programmes under Choice Based Credits and Semester System (OBE) for Undergraduate Programme were implemented in this University w.e.f 2019 admission.
- 2. The meeting of Curriculum, Syllabus and Restructuring Committee, as per paper read (2) above, based on the detailed discussion, resolved to recommend to the Academic Council certain modifications to the Regulations for Choice Based Credits and Semester System (OBE) for Undergraduate Programme- Implemented with effect from 2019 admission.
- 3. The following amendments are made at the existing Regulations for Choice Based Credits and Semester System (OBE) for Undergraduate Programme 2019 admission, as approved by the Vice Chancellor.

Amendment 1

That the existing clause 3.13 of the Regulations for Choice Based Credit and Semester System for Under Graduate Programme in Affiliated Colleges- 2019 (in OBE- Outcome Based Education System) be substituted by the following.

3.13: Those students who have registered for First Degree (Under Graduate) programmes under the Regulations for Choice Based Credit and Semester System for Under Graduate Curriculum 2014 (KUCBCSSUG2014) in force from 2014 to 2018 admissions, but could not successfully complete the programme due to discontinuation after registration at First or second or third or fourth or fifth semester examination, may be granted readmission on the discontinued semester subject to availability of vacancy and the age limit prescribed under clause 3.8, on cancellation of their previous examination registration. The candidates so readmitted shall also take ESE of all previous semesters as per the scheme and syllabus in force at the time of all previous semesters fulfilling all requirements as provided in the regulation by receiving such additional instructions as may be prescribed by and to the satisfaction of the department and college.

Amendment 2

That the existing clause against serial number 13 under clause 8.5 of the Regulations for Choice Based Credit and Semester System for Under Graduate Programme in Affiliated Colleges- 2019 (in OBE- Outcome Based Education System) be substituted by the following. 8.5 (13):The student should get minimum of 40% mark of aggregate and 40% separately for

ESE, for a pass in the project.

Amendment 3

That the existing clause 9.5 of the Regulations for Choice Based Credit and Semester System for Under Graduate Programme in Affiliated Colleges- 2019 (in OBE- Outcome Based Education System) be substituted by the following.

9.5: A candidate securing not less than 40% of aggregate marks of a course with not less than 40% in End Semester Evaluation (ESE) shall be declared to have passed in that course. A minimum of grade point 4 with letter grade E is needed for the successful completion of a course.

Amendments 4

That the existing clause 9.6 of the Regulations for Choice Based Credit and Semester System for Under Graduate Programme in Affiliated Colleges- 2019 (in OBE- Outcome Based Education System) be substituted by the following.

- 9.6: Appearance for Continuous Evaluation (CE) and End Semester Evaluation (ESE) are compulsory and no grade shall be awarded to candidate if she/he is absent for CE/ESE or both. ESE or CE marks without fraction shall be communicated to the Controller of Examinations. While finalising the results for the purpose of securing pass minimum as provided in the regulations, decimal part with 0.5 or above shall be rounded to next whole number and below 0.5 be ignored as if pass minimum is fixed at that stage. Absence of a candidate in CE or ESE shall be denoted with the symbol 'X' in Tabulation Register and Grade Card.
 - 4. The Vice-Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(1) of Kannur University Act 1996 and all other enabling provisions read together with, approved the modified Regulations for UG Programmes (CBCSS) w.e.f 2019 admission and accorded sanction to implement the modified Regulations for UG Programmes under Choice Based Credit and Semester System in Affiliated Colleges w.e.f 2019 admission.
 - 5. The relevant clauses in the regulation shall be read as detailed in para 3 after amendment.
 - 6. The U O read (1) stands modified to this extend.
 - 7. Amended part of the Modified regulation is uploaded in the university website.
 - 8. The amended part of the Regulations for UG Programmes under Choice Based Credit and Semester System w.e.f 2019 (OBE) admission are appended.
 - 9. Orders are issued accordingly
